The great-great grandfather of Gordon Scott Lee came to N.S.W. with Governor Phillip in 1788 in Imperial Service and his son William was one of the first 13 settlers in the Bathurst District and founder of the family known as the Bathurst Lees -- (from his father's words on the AWM Honour Roll entry for Roy Lee) Presented 1922. **Gordon committed suicide in 1922. This was attributed to war service.**

He is the younger son of Mr. William Lee, of Bathurst, and a descendant of the late William Lee, one of the original pioneers of the western district. Private Lee was following engineering at the time of enlistment, and volunteered as an engineer, but there not being a vacancy elected to go with the infantry rather than be left behind. Private Lee's brother is just about to go into camp in Queensland.

The attached communication received from the father of the late ex No.1979 L/Cpl. G.S.LEE, M.M., 2nd Battalion, is referred for favor of necessary enquiry regarding the circumstances surrounding this soldier's death and report as to whether the writer's statement concerning the effects of war service in relation thereto may be accepted as authentic in so far as it involves the issue of a Memorial Plaque and Scroll.

It should be noted that suicide cases are not debarred by the regulations from participation except where the deaths are accompanied by particularly disgraceful circumstances, but it is a first essential that the cause of death should be attributed to war service.

Your prompt attention to this matter will be appreciated.
